- In progress: Could Northfield sponsor a citywide leaf pickup, Tracy is attempting to identify a vendor, further discussion at that point. (\$20K placeholder until firm estimate received).
 Joe's lawn care proposed \$137 per house, per event. Tracy will pursue other options before moving forward.
