OLD BUSINESS

 Northfield Memorials: Barbara and Gay reported that the benches have been delivered, and will be assembled by Lawnco. Site work will begin soon.

NEW BUSINESS

- City Meeting logistics changes Ordinance 25.03. The mayor will call a special meeting for the second reading after he talks with Dominion about the location and schedule changes.
 Proposed changes include: first Monday of each month at 6pm. If the meeting is on a Holiday, it will be held on the following Tuesday. It was also proposed to have a regular December meeting (this is usually cancelled). The meeting location will be either 5900 or 6000 Hunting Road.
- Everlan noise complaints. The mayor will speak with Dominion/Everlan regarding the issue with early morning trash pickup that is disturbing residents. He believes we have an existing agreement regarding disturbances to the neighborhood.
- It was noted that some residents have received letters from the Sauls Seismic regarding inspections on their homes (due to the blasting on US42/I264).

PARKING LOT

- In progress: NF Main Entrance signage and lighting update. Tracy will get options so that we will be ready when the highway construction impact is known. In the interim, residents will be polled for their input.
- In Progress: Fence down along US42. John advised us to get the required approval from KYTC before proceeding. Tracy will continue to pursue, including contacting someone from the state. Paused for construction.
- Lime Ridge sidewalk installation and landscaping. Waiting for survey results.
- Abandoned properties in the city. The options given by John were as follows:
 - Create an Abandoned Property Ordinance, (City of Louisville has an existing one).
 This would allow us to issue a tax lien on the properties, (this would require a Code Enforcement Board).
 - Harden our city nuisance ordinance. This is to be discussed at a future meeting. He
 also offered to draft letters to the property owners. He will need photos of the
 properties, as well as information connecting the issues to our nuisance ordinance.
- Charlie suggested an increase to the insurance premium tax to increase revenue. Per John,
 it would require necessary paperwork sent to Frankfort 100 days prior to July 1. Therefore
 in March. Up for future discussion.

ADJOURN

There being no further business, the meeting was adjourned at 8:35 p.m. The next meeting of the Northfield City Council will be held on Tuesday September 2, 2025 at Everlan (pending passage of Ordinance 25.03). There will be a special meeting on Saturday August 16 at 09:30 a.m. to conduct a second reading of 25.03.
